Gift Aid Notes

- You can cancel the declaration at any time by notifying Racing Welfare it will then not apply to
 donations you make on or after the date of cancellation or such later date as you specify.
- 3. If, in the future, your circumstances change and you no longer pay income tax and/or capital gains tax

equal to the tax that Racing Welfare reclaims, you should cancel your declaration (see note 1).

- 4. If you pay tax at the higher rate, you can claim further tax relief in your Self Assessment Tax Return.

The Direct Debit Guarantee

- This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits.
- If there are any changes to the amount, date or frequency of your Direct Debit, Racing Welfare will notify you five working days in advance of your account being debited or otherwise agreed. If you request Racing Welfare to collect a payment, confirmation of the amount and date will be given to you at the time of request.
- If an error is made in the payment of your Direct Debit by Racing Welfare or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society.
 - If you recieve a refund you are not entitled to, you must pay it back when Racing Welfare asks you to.
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.
