# Terms and Conditions

1. THE FOLLOWING TERMS AND CONDITIONS SET OUT THE APPLICABLE TERMS AND CONDITIONS FOR NOMINATION FOR AND PARTICIPATION IN THE RACING WELFARE LIFETIME IN RACING AWARDS (THE "AWARDS").
2. THE AWARDS REGIONS ARE: 1. NORTH; 2. SOUTH; 3. EAST; 4. WEST
3. SUBMISSIONS MAY BE SENT TO RACING WELFARE FROM 10AM ON 4TH JULY 2022 UNTIL 3PM ON 29 JULY 2022. NO SUBMISSIONS WILL BE CONSIDERED OUTSIDE OF THIS WINDOW.
4. NOMINATIONS FOR THE AWARDS CAN BE MADE BY ANYONE CONNECTED TO THE NOMINEE INCLUDING EMPLOYERS, COLLEAGUES AND FAMILY MEMBERS.
5. NOMINEES CAN COME FROM ANY SECTOR OF THE INDUSTRY INCLUDING, BUT NOT LIMITED TO, STABLE STAFF, STUD STAFF, TRAINERS, OWNERS, BREEDERS, TRAVELING STAFF, RACECOURSE STAFF, OFFICE STAFF, MEDIA AND ALL ANCILLARY SERVICES.
